Delegation of Responsibility</p> <p>Title 22<br/>Sec. 11.25<br/>Pol. 204</p> | <p>The Superintendent may close the schools, delay the opening of schools, or dismiss school early for emergency reasons and to protect the health and safety of students and staff members, and shall prepare rules for the proper and timely notification of concerned persons in the event of such emergency closing.</p> <p>The Superintendent shall develop guidelines which allow students to enter schools, and to leave schools, under exceptional conditions so that variances with the normal school schedule may be accommodated. Such guidelines shall consider such things as inclement weather, family illness, urgent reasons and other similar circumstances or for other appropriate causes as determined by the Superintendent.</p> <p>References:</p> <p>School Code – 24 P.S.
